KEYNOTE SPEAKER

Madeline Bell, President and CEO, Children's Hospital of Philadelphia



Ms. Bell began her career as a pediatric nurse at CHOP in 1983, later leaving the organization to move into hospital administration. She returned to CHOP in 1995 to lead Home. Care and Case Management, and has since held a number of leadership positions, advancing from Vice President to Senior Vice President to Executive Vice President to Chief Operating Officer. In 2015, she assumed the title of President and CEO. Ms. Bell has made numerous contributions to CHOP, including the development of one of the largest pediatric ambulatory networks in the country, the implementation of a single-platform electronic health record, the expansion of the Hospital's 4-million-square-foot campus, and the development of many nationally recognized clinical and family-centered care programs. Her background in patient care has given her a deep appreciation for the clinical world, and she always stays focused on improving care for children.
