This one-day pediatric ICU course will focus on the medical complexities of the pediatric ICU patient.

Topics will include:

- Multidisciplinary team members and their unique roles
- The impact of sedation medication and the impact of ICU delirium
- Common medical equipment and associated precautions
- ICU evaluation and common interventions including early mobility, progressive mobility and ECMO mobility
- Discharge planning and post-acute illness
