# **Virtual Conference**

This conference is intended for the multidisciplinary team: physicians, nurses, social workers, child life specialists, pharmacists, and patient service representatives.



#### **Course Overview**

Pediatric sexual assault is an alarming health concern producing substantial consequences medically, psychologically, and legally. It is estimated that 1 in 4 girls and 1 in 13 boys experience child sexual assault, and many other cases remain undetected or unreported. Experiencing child sexual assault can result in short- and long-term physical, mental, and emotional health consequences. Therefore, the need for high quality medical, forensic and behavioral health services for pediatric victims of sexual assault victims is paramount

This conference showcases a multidisciplinary approach to the care of pediatric sexual assault victims with expert presentations from Pediatric Emergency Medicine, Child Abuse, Adolescent Medicine, Laboratory Medicine, Social Work, and District Attorney Offices. The goal of this conference is to outline a developmentally appropriate, trauma-informed approach to high quality medical, forensic, and behavioral health care. The Sexual Assault Response Team (SART) Conference showcases the coordinated response to best take care of pediatric sexual assault victims.

# **Course Objectives**
