## Call For Abstracts

Children’s Hospital of Philadelphia Global Health Center is accepting abstracts for presentation at this year’s conference, with the theme **“Rising Up Together: Child Health in the Face of Climate Change,”** to be held Friday, Oct. 25 and Saturday, Oct. 26, 2024. Abstracts may be related to any aspect of global child health, including those focusing on addressing the impact of climate change on child health. Abstracts in the categories of original research, program evaluation/public health, quality improvement/program evaluation, clinical care, and personal narratives will be considered. Please note that personal narratives must include background, summary of experience, and key takeaways from your experience in a global setting.

Submitted abstracts should address *any* aspect of global child health – “global-global” or “local-global.” The themes below relate to this year’s topic and are provided to stimulate thought as you prepare to submit and share your work:

- The role of health systems in addressing or mitigating the impact of climate change on child health
- Tools or interventions for educating caregivers and the public about the impact of climate change on child health
- Addressing the unequal impact and contribution of climate change between high-income countries (HIC) and low- and middle-income countries (LMIC)
- Engaging with and highlighting the work of Indigenous and other marginalized communities to address climate change
- Any other topic of interest to the pediatric global health community

## Abstract Selection Process

Abstracts will be selected for presentation based on quality, merit and relevance to the pediatric global health community. Projects may be in various stages of development. Following blinded peer review, an abstract review committee will determine acceptance. Abstracts will be accepted for poster or short oral presentations at the conference. Peer reviewers and the abstract review committee will assess abstract submissions based on the following criteria:

- Relevance of topic
- Originality
- Pediatric global health merit and importance
- Quality of research design and data analysis
- Quality of conclusions
- Clarity of writing

## Poster Presentation Format

Every person or group with an accepted abstract will be asked to present in a poster walk or short oral session. During the poster-walk session, a moderator assigned to each group will coordinate the order of the presentations and questions. Whether a poster is in print or e-form, presenters will be asked to give a five-minute overview of their work and have time to answer one or two audience questions. Instructions for preparing posters (including format and size) will be provided to the contact author with the presentation acceptance notification by the end of July 2024.

## General Abstract Submission Policies

- Electronic submissions are due **Monday, Jul. 1, 2024, by 11:59 PM (ET)**.

- Abstracts should be no longer than 300 words
- There is no limit to the number of abstracts submitted by each author, but the submission of multiple, similar abstracts from the same investigator is discouraged. Each abstract submitted should be for a distinct project
- Abstracts submitted or presented at other meetings may be submitted for consideration
- Upon submission, the submitting author verifies that all authors have agreed to submit the abstract and that all submitted information is true
- Abstract submissions are open to all including students, researchers, clinicians, and public and global health practitioners

Notification of abstract acceptance will be emailed to the contact author listed on the abstract after Monday, Jul. 29, 2024. If you have not received notification by Monday, Aug. 5, 2024, please contact the CHOP Global Health Center for assistance.
